

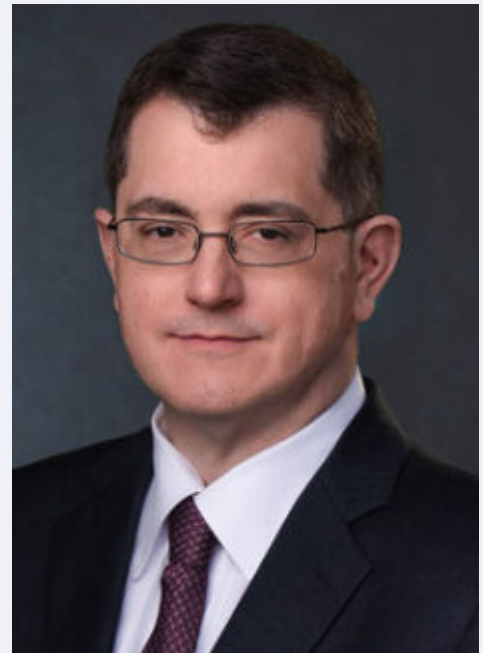
Brian M. Seelinger
