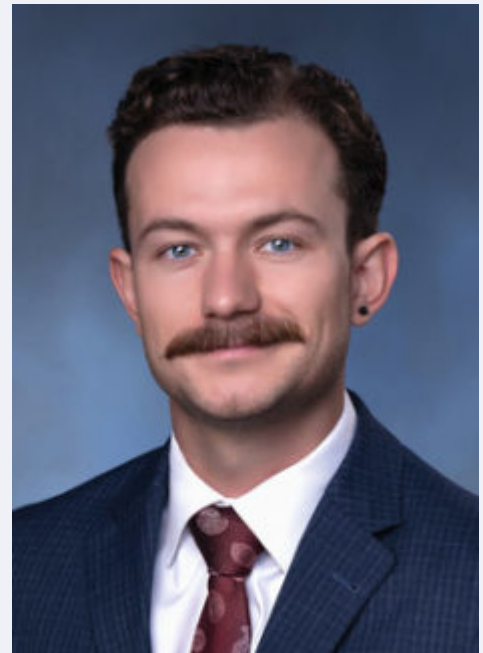


## Mason D. Bracken

- Successfully defended a city's new, comprehensive landlord-tenant ordinance from attack on constitutional and statutory grounds by a landlords' association. The ordinance created the city's first comprehensive rental registration and licensing program. Worked as part of the team that obtained an order denying a preliminary injunction against enforcement of the ordinance—thus allowing implementation to proceed. Conducted oral argument at a state court hearing. Obtained dismissal of most claims. Favorably settling remaining claims by preserving the new rental registration and licensing program in exchange for revision of only one minor subsection of the ordinance
