

## Philip J. Seaver-Hall

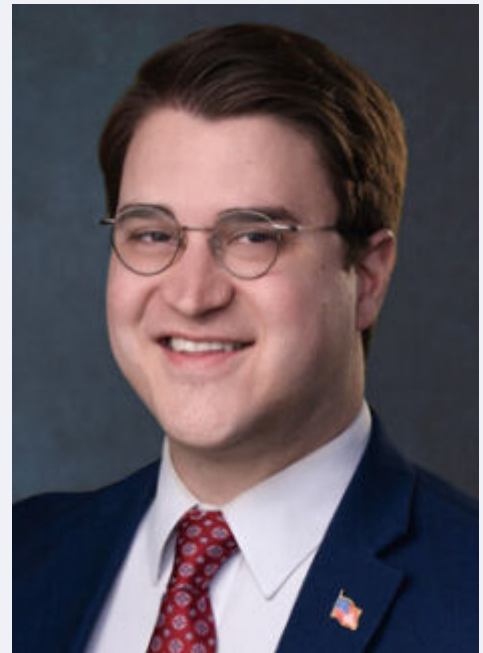
### Associate
